### About this document

This document is a Supplementary Product Disclosure Statement issued by Vanguard Investments Australia Ltd ('Vanguard'). This Supplementary Product Disclosure Statement updates the Vanguard Global Aggregate Bond Index (Hedged) ETF Product Disclosure Statements dated 1 November 2018 and must be read in conjunction with the PDS. Words and expressions defined in the PDS have the same meaning in this Supplementary Product Disclosure Statement.

Except to the extent amended by this Supplementary Product Disclosure Statement or updated on our website, the PDS remains in full force.

**On page 4** of the PDS, the section entitled "**Investment objective**" is deleted and replaced with the following:

"The Fund seeks to track the return of the Bloomberg Barclays Global Aggregate Float Adjusted and Scaled Index hedged into Australian dollars, before taking into account fees, expenses and tax."

**On page 4** of the PDS, the section entitled "**Index Information**" is deleted and replaced with the following:

"The Bloomberg Barclays Global Aggregate Float-Adjusted and Scaled Index hedged into Australian dollars is a market value weighted index comprised of global investment grade securities (bonds). This includes government, government-related, corporate and securitised fixed rate bonds from both developed and emerging market issuers.

Securities are included in the index based on issue size, amount outstanding and security type. New market inclusion is reviewed on an annual basis through the Bloomberg index governance process. To be included, debt securities must be investment grade and sufficiently tradable, convertible and hedgeable for offshore investors.

The index methodology uses standard rules based index methodology and market capitalisation weighting. The methodology includes the rules for constituent rebalancing, constituent inclusion, pricing sources, frequency and timing. The Index was not created by, and is not managed by, a related body corporate of Vanguard."

"**Benchmark** in relation to the Vanguard Global Aggregate Bond Index ETF means the Bloomberg Barclays Global Aggregate Float Adjusted and Scaled Index hedged into Australian dollars"
